On October 31, 1973, an anonymous caller advised the Detective Division that a man living in the vicinity of HARWOOD AVENUE and HEATHER ROAD in HOMEWOOD, ILL., was performing lewd acts upon young boys in an apartment.

This caller further advised that one of the youths who was involved was a boy named [REDACTED]

An investigation was commenced and it was subsequently learned that a subject known as STEVEN GURWELL, of 22 [REDACTED] HEATHER ROAD, HOMEWOOD, ILLINOIS, who is a white male, approximately 30 years of age, performed a lewd act upon the person of one [REDACTED] which constituted the offense of indecent liberties with a child.

An anonymous call, which was received on 10/31/73, caused an investigation to be made into the allegation that a thirty year old white male subject, whose name and address were unknown, was performing lewd acts upon the persons of a number of youths who were frequenting his apartment. The anonymous caller had also advised that one of the youths involved was named [redacted]. No first name or address was known.

On 11/1/73, [redacted] was contacted by this department, and advised of the situation. At 1630 Hrs., that date, [redacted] reported to this station with his son, [redacted] who related the following:

Some time in August, 1973, he and a companion named [redacted] were walking on PALMER AVENUE in the Village of Homewood, when a subject now known as STEVEN GURWELL, age approximately 30 years, of 22 [redacted] HEATHER RD., HOMEWOOD, ILLINOIS, greeted them. Both boys returned the greeting and went on their way. Several times, later in the month, the [redacted] boy saw this subject at FAT ALBERT'S RESTAURANT, located at RIDGE ROAD and DIXIE HIGHWAY, in the Village of Homewood, Illinois. On occasion, he would speak to GURWELL, and, on one of these occasions, GURWELL advised that he would drive the boy home. [redacted] accepted the ride, but, instead of driving the boy home, GURWELL drove to his own apartment and invited the youth inside to have a beer.

The word was soon spread by [redacted] to several of his friends, that GURWELL was willing to give them beer. Throughout the month of September, [redacted] and four of his companions went to GURWELL'S APARTMENT at 22 [redacted]

Heather Road, and each time they were given beer. This activity continued into the month of October, and, on October 4, 1973, [Redacted] and a friend, [Redacted], went to the apartment. After GURWELL gave them each a can of beer, he asked if they wanted to see some movies. Both boys stated they would, and GURWELL led them to an upstairs bedroom, where he had a projector. He then showed a pornographic film. Part way through the film, GURWELL removed all of his own clothing and pulled the two boys' trousers and under-shorts down to their knees. GURWELL then performed acts of oral copulation upon both the boys throughout the rest of the film.

After receiving this information, [Redacted] AVE., HOMEWOOD, ILLINOIS, was contacted by this station and advised of the situation. [Redacted] reported to the police department with his son, [Redacted] who, in the presence of [Redacted] and his son, related the same account as that given by [Redacted]. Both parties advised that they wished to sign complaints against GURWELL for INDECENT LIBERTIES WITH A CHILD.

Further questioning revealed the fact that GURWELL shares the apartment with a subject named CHUCK, now believed to be CHARLES J. REHLING, whose name appears on the water files for the address of 22 [Redacted] HEATHER ROAD. It was also learned that GURWELL is presently out of state and will return sometime in mid-November.

On 11/1/73, an investigation was commenced to determine the validity of an anonymous call that was received by this department. The anonymous caller had advised that a male, white subject, who lived somewhere in the vicinity of HARWOOD AVENUE and HEATHER ROAD, HOMEWOOD, ILLINOIS, had been supplying a number of juveniles with beer. The caller further advised that this same subject was performing lewd acts with these youths. The only other information obtained was that one of the boys was named [REDACTED]. The first name and address was unknown.

Investigation revealed the fact that a [REDACTED] lived at 185 [REDACTED] LEXINGTON AVENUE, HOMEWOOD, ILLINOIS. [REDACTED] was contacted, and advised of the situation. [REDACTED] subsequently reported to this station with his son, [REDACTED] who related several accounts of his activities in an apartment located at 22 [REDACTED] HEATHER ROAD, HOMEWOOD, ILLINOIS.

[REDACTED] stated that he had been touched and fondled by a subject known to him as STEVEN GURWELL, on several occasions during the month of OCTOBER, 1973. On this particular occasion, which took place on the afternoon of 10/13/73, [REDACTED] and four of his friends, one of whom was [REDACTED] went to GURWELL'S APARTMENT at the HEATHER ROAD address for the purpose of drinking beer. [REDACTED] and his friends had been at the apartment on numerous occasions prior to this incident, and each time had been given beer by GURWELL.

While at the apartment on this occasion, GURWELL advised that he was going to take [REDACTED] to ACAPULCO, MEXICO on a vacation. While GURWELL was

While investigating several cases of indecent liberties with children, it was learned that _____ of 185 _____ LEXINGTON AVENUE, HOMEWOOD, ILLINOIS, and a _____ of 184 _____ PALMER AVENUE, HOMEWOOD, ILLINOIS, had been frequenting an apartment located at 22 _____ HEATHER ROAD, HOMEWOOD, ILLINOIS.

Both _____ were interviewed at this station. The fathers of both boys were present during the interview.

Both boys stated that they had been going to an apartment located at 22 _____ HEATHER ROAD for some time. This was due to the fact that one of the residents of the apartment, now known as STEVEN GURWELL, age approximately 30 years, had been supplying _____ and a number of their friends, with beer for some time.

On the afternoon of OCTOBER 7, 1973, _____ went to the apartment with the intention of drinking beer. They were admitted to the premises by GURWELL who also gave them a can of beer. While the two boys were drinking the beer, GURWELL asked them if they wanted to see some movies. Both boys stated that they did, and GURWELL took them to an upstairs bedroom, where he showed a pornographic film. During the film, GURWELL removed all of his own clothing and pulled both the boys' trousers and shorts down to their knees. GURWELL then performed an act of oral copulation upon the person of _____ while at the same time, he fondled and stroked the penis and crotch of _____. This lasted for the duration of the movie, approximately 5 minutes.

In the process of investigating a series of complaints regarding indecent liberties with children, it was learned that a juvenile named [REDACTED] had been frequenting an apartment at 22 [REDACTED] HEATHER ROAD, for the purpose of obtaining beer. It was also learned that [REDACTED] had been the victim of indecent liberties that were performed on him by a white male, age approximately 30 years, named STEVEN GURWELL, who resides at that location with a subject known as "CHUCK".

Upon receipt of this information, [REDACTED] the father of [REDACTED] was contacted and advised of the situation. [REDACTED] reported to this station with his son at 2130 Hrs., on 11/1/73. At this time, [REDACTED] related the following account:

He had been to GURWELL'S APARTMENT on several occasions and had been given beer. On 10/17/73, in the afternoon hours, [REDACTED] proceeded to GURWELL'S APARTMENT and was admitted to the premises by GURWELL.

After obtaining a can of beer from the subject, [REDACTED] was asked if he wanted to see a movie. [REDACTED] replied "Yes", and was ushered to an upstairs bedroom, where GURWELL showed a pornographic film. During the film, GURWELL removed all his own clothing and, towards the end of the film, slid his hand down the front of JAMES' trousers and grasped his penis. [REDACTED] protested and GURWELL removed his hand. [REDACTED] left the apartment a short time later, and returned to his home.

In August of 1973, REHLING departed for EUROPE with [redacted] and remained abroad for three and one-half weeks. The cost of this trip was \$4,500.00.

Upon returning to HOMEWOOD, ILLINOIS, an attempt was made to contact GURWELL at TX 214-522-6143 in DALLAS, TEXAS, to determine how [redacted] was to get back to MISSOURI. Contact was made and subsequently, REHLING purchased an airline ticket for [redacted] and sent him back to MISSOURI.

In late September or early OCTOBER, ALAN HITCHCOCK (GURWELL) contacted REHLING by telephone and stated that he would be passing through town. (Our investigation insticates that GURWELL was in the HOMEWOOD vicinity since late August or early September of 1973. He did not however contact REHLING until late September or early October.) REHLING told HITCHCOCK (GURWELL) that he was welcome to stay at his apartment if he chose to do so.

Some time later, HITCHCOCK (GURWELL) telephoned REHLING and advised him that he was at the HOMEWOOD, ILLINOIS CENTRAL RAILROAD Station, and requested that REHLING pick him up.

GURWELL stayed with REHLING from that time (late September of very early October) until October 25, 1973, at which time he left the state.

While staying with REHLING, GURWELL borrowed \$600.00 and purchased a tan 1966 VOLKSWAGEN from a family in HAZEL CREST, ILLINOIS. It was also learned that the family had forgotten and left the license plates on the car at the time of sale. 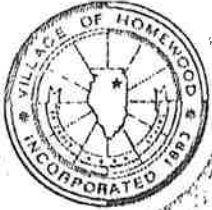

An investigation by this department has determined that a subject known as Steven Gurwell, who was residing at 22 [REDACTED] Heather Rd. this village, had committed five separate acts of deviate sexual conduct upon the persons of several youths who are under the age of sixteen years. These offenses were committed during the period of October 4 - 21, 1973. On November 7, 1973 a felony warrant charging John Doe Aka Steven Gurwell with the offense of Indecent Liberties With A Child in violation of Chapter 38, Section 11-4 (a) (2), Illinois Revised Statutes. The warrant was issued by Cook County Circuit Court District 6. On November 5th and 6th, 1973 a Mr. Charles J. Rehling of 22 [REDACTED] Heather Rd. Homewood, Illinois advised Detective Sergeant Franklin E. Flannery and Detective Richard H. Braun that the individual known to him as Steven Gurwell, Aka, Alan Hitchcock, had departed Homewood on or about October 25, 1973 and was enroute to Dallas, Texas.

Also on November 6, 1973 Rehling identified Dallas Police Department Photo Number 121699 of John David Norman as being identical to the person that was known to him as Steven Gurwell.
